THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 484B.207 is hereby amended to read as follows:
2 484B.207 1. ~~The~~ *Except as otherwise provided in NRS 486.351,*
3 *the* driver of a vehicle overtaking another vehicle proceeding in the same
4 direction shall pass to the left thereof at a safe distance and shall not again
5 drive to the right side of the highway until safely clear of the overtaken
6 vehicle.
7 2. Except when overtaking and passing on the right is permitted, the
8 driver of an overtaken vehicle shall give way to the right in favor of the
9 overtaking vehicle upon observing the overtaking vehicle or hearing a
10 signal. The driver of an overtaken vehicle shall not increase the speed of
11 the vehicle until completely passed by the overtaking vehicle.
12 3. A person who violates any provision of this section may be subject
13 to the additional penalty set forth in NRS 484B.130.
14 **Sec. 2.** NRS 484B.210 is hereby amended to read as follows:
15 484B.210 1. ~~The~~ *Except as otherwise provided in NRS 486.351,*
16 *the* driver of a vehicle may overtake and pass upon the right of another
17 vehicle only under the following conditions:

1 (a) When the driver of the vehicle overtaken is making or signaling to
2 make a left turn.

3 (b) Upon a highway with unobstructed pavement which is not occupied
4 by parked vehicles and which is of sufficient width for two or more lines
5 of moving vehicles in each direction.

6 (c) Upon a highway with unobstructed pavement which is not marked
7 as a traffic lane and which is not occupied by parked vehicles, if the
8 vehicle that is overtaking and passing another vehicle:

9 (1) Does not travel more than 200 feet in the section of pavement
10 not marked as a traffic lane; or

11 (2) While being driven in the section of pavement not marked as a
12 traffic lane, does not travel through an intersection or past any private way
13 that is used to enter or exit the highway.

14 (d) Upon any highway on which traffic is restricted to one direction of
15 movement, where the highway is free from obstructions and of sufficient
16 width for two or more lines of moving vehicles.

17 2. The driver of a vehicle may overtake and pass another vehicle upon
18 the right only under conditions permitting such movement in safety.

19 3. The driver of a vehicle shall not overtake and pass another vehicle
20 upon the right when such movement requires driving off the paved portion
21 of the highway.

22 4. A person who violates any provision of this section may be subject
23 to the additional penalty set forth in NRS 484B.130.

24 **Sec. 3.** NRS 486.351 is hereby amended to read as follows:

25 486.351 1. ~~{A}~~ *Except as otherwise provided in this section, a*
26 *person* ~~{, except a police officer in the performance of his or her duty,}~~
27 *shall not drive a motorcycle or moped* ~~{between}~~ :

28 (a) *Between* moving or stationary vehicles occupying adjacent traffic
29 lanes.

30 ~~{2. Except as provided in subsection 3, a person shall not drive a~~
31 ~~motorcycle, moped or trimobile abreast}~~

32 (b) *Abreast* of or overtake or pass another vehicle within the same
33 traffic lane.

34 2. *The provisions of subsection 1 do not apply to a police officer in*
35 *the performance of his or her duty.*

36 3. *A person may drive a motorcycle between* ~~{moving or}~~ *stationary*
37 *vehicles occupying adjacent traffic lanes and traveling in the same*
38 *direction as the motorcycle provided that:*

39 (a) *The person drives in a manner that is reasonable and proper,*
40 *having due regard for the traffic, surface and width of the highway, the*
41 *weather and other highway conditions; and*

42 (b) *The motorcycle, while driving between such vehicles* ~~{}~~ *is*

43 ~~{(1) Does}~~ *does not travel at a speed which is more than 10 miles*
44 *per hour* ~~{faster than the speed of those other vehicles; and~~

45 ~~{(2) Does not exceed a maximum speed of 30 miles per hour.}~~

1 **4.** Motorcycles and mopeds may, with the consent of the drivers, be
2 operated no more than two abreast in a single traffic lane.

3 **Sec. 4.** This act becomes effective on January 1, 2014.
